Teamsters TeamLegal is a nationwide program ready to provide you with legal assistance for civil and criminal incidents, and preparation for Grand Jury hearings. TeamLegal is available even when you are being represented by other attorneys, and remains in effect during extra jobs. Any dues paying member of the Teamsters who works in law enforcement may participate in TeamLegal.

MNTLEL is a fraternal, non-partisan division of Teamsters Local 320 that advises the Local on a wide range of issues including wages, benefits, working conditions, bargaining, training and pending legislation. MNTLEL membership is included in your Local 320 Dues.
